

# Church Voter Guides, what is a 501c3-Compliant, Nonpartisan Guide



### **Church Voter Guides**

Church Voter Guides is an independent 508c1a faith-based nonprofit organization. We serve the public by providing objective research and education on matters specifically of interest to Christians, primarily through the production and distribution of 501c3-compliant, nonpartisan Voter Guides.

Church Voter Guides does not endorse or oppose any candidates for public office or any political party.

We are based in Colorado Springs, and the 2021 City Council election in our hometown is our inaugural project. Our Voter Guide for this election is being distributed electronically, both through our interactive website and by downloadable and printable PDF files, one for each electoral district. It is being promoted through a wideranging network of area churches, faith-based non-profit organizations, mainstream and social media, and other means.

### What makes a Voter Guide 501c3-Compliant and Nonpartisan?

Federal tax law permits nonprofit 501c3 organizations to develop and distribute materials about political candidates' positions on issues, in order to educate voters impartially and on a nonpartisan basis, meaning that it is free from party affiliation, bias, or designation. The IRS states that 501c3 organizations may conduct any range of activities to promote voter participation and educate voters so long as it is nonpartisan. But, 501c3 organizations are explicitly prohibited from supporting or opposing candidates for public office.

### 501c3 nonprofits MAY:

- Conduct or Promote Voter Registration
- Educate Voters on the Voting Process
- Distribute Nonpartisan Sample Ballots, Candidate Questionnaires, or Voter Guides
- Organize Get-Out-the-Vote Activities
- Encourage and Help People to Vote
- Educate the Candidates on Issues Important to Your Organization
- Continue to do Issue Advocacy During an Election

# INTRODUCTION TO THE VOTER GUIDE

So, first and foremost: Church Voter Guides does NOT endorse or oppose any candidates for public office or any political party.

Second, all of our staff and volunteers are required to act in a nonpartisan manner when working for or representing the organization and the creation of the Voter Guide.

Third, we do not edit, revise, or editorialize candidate responses to our Questionnaire. We do not even correct typos. Candidate answers are published verbatim, ensuring that their responses accurately represent their positions and perspectives on these issues. We then simply share this information through the Voter Guide, and you decide whom you believe to be the best candidate.

The purpose of our Voter Guides is to educate and inform voters of each candidate's positions on a variety of policy issues that they are likely to address if elected. As a Voter Guide designed to be distributed through Churches, we ask the candidates questions on topics that are of utmost interest to the Christian voter.

To be fair and impartial, we reached out by email and phone to all 21 candidates running for City Council in the 2021 Colorado Springs Municipal Election to be held on April 6th, inviting them to answer our Questionnaire. Two never responded; of the rest, most chose to participate, while some did not. Candidate information is presented in the same order as the Candidates are listed on the ballot. If a Candidate did not respond at all, or did not choose to participate, or did not choose to respond to certain answers in the Questionnaire, then that is noted where applicable.

# CITY COUNCIL RESPONSIBILITIES / DISTRICT CANDIDATES

As the legislative branch of government for the City of Colorado Springs, council members are elected to four-year terms and are paid an annual stipend of \$6,250. They are responsible for:

-Appointing the city auditor and the council administrator

- -Approving the city budget
- -Establishing tax rates
- -Serving as the governing board of Colorado Springs Utilities
- -In its role as Colorado Springs Utilities Board of Directors, appointing the Chief Executive Officer
- -Setting policies and passing ordinances and resolutions to govern the city
- -Performing the Mayor's duties in his/her absence (President of council)
- -City Council Rules and Procedures

# **GENERAL MUNICIPAL ELECTION | APRIL 6, 2021**

The City Clerk will be mailing ballot packets for the April 6, 2021 General Municipal Election to registered, active voters who reside within the corporate boundaries of the City of Colorado Springs on Friday, March 12, 2021. If you do not receive your ballot packet by March 17, 2021, please contact the City Clerk's Office. The April 6, 2021 election is an all-mail ballot election only. City elections have been mail ballot only since 2005.



What does UOCAVA mean? UOCAVA means Uniformed and Overseas Citizens Absentee Voting Act

Am I a UOCAVA voter? UOCAVA electors are:

- A member of the Uniformed Services or Merchant Marines on active duty, absent from their place of residence;
- An eligible spouse or dependent of the member described above; or
- A U.S. citizen residing outside the U.S.

Can I receive my ballot by email or fax?

# FREQUENTLY ASKED QUESTIONS

#### WHAT IS A MAIL IN BALLOT?

A mail ballot election provides every eligible active voter, residing within the limits of the City of Colorado Springs, a ballot indicating the issues and candidates for their specific City Council District. The mail ballot packet is mailed to the address listed on voter registration records.

All active voters will receive a ballot mailed to the mailing address shown on the voter registration records unless a request for an absentee ballot is received (see information below). If you have moved or changed addresses and have not updated your voter registration, the ballot will not be forwarded and will be returned to the City Clerk's Office as undeliverable.

#### WHAT DOES THE MAIL BALLOT MEAN TO ME?

- There will be no voting at precinct polling places.
- There will be no early voting.

#### WHEN WILL YOU MAIL THE BALLOTS?

We anticipate mailing ballots on March 12, 2021. If you do not receive a ballot by Wednesday, March 17, 2021, and believe you are an eligible active voter within the City limits, contact the City Clerk's Office at (719) 385-5901, option 4 or email us at elections@coloradosprings.gov(link sends e-mail).

#### WHAT IS THE TYPICAL RETURN RATE FOR MAIL BALLOTS?

Historical voter turnout (the percentage of total votes counted divided by active registered voters) can be found on our Election Archives page coloradosprings.gov/election-history. Just look for the Results Summary. If you are curious about the daily volume of ballots scanned, you can review the Daily Reports for the last four municipal elections. Election Daily Reports.

The Daily Report indicates the number of ballots scanned each day of processing beginning, March 13, 2021.

#### AM I AN ACTIVE VOTER?

To verify your current voter status, go to http://www.govotecolorado.com/(link is external). Per City Code 5.1.102 we only mail to active registered electors. If you are inactive and wish to vote, see HOW DO I GET A BALLOT IF I AM INACTIVE? below.

#### HOW CAN I FIND OUT THE RESULTS OF THE ELECTION?

Unofficial results of the City Election will be posted on coloradosprings.gov/election. The initial unofficial results should be available by 7:30 PM. Additional updates to the unofficial results will be posted throughout the evening until all ballots have been counted.

#### **CITY COUNCIL'S PURPOSE**

What do you view as the purpose and role of the Colorado Springs City Council?

#### **ANSWER:**

One hundred percent public service. Nothing more, nothing less. On January 8, 2021, I presented a cry for help to the Colorado Springs City Council. I asked this Council to enact a one year moratorium on all proposed residential rate increases. Residents were being served with eviction notices, their automobiles were being repossessed and towed away. The Broadmoor Hotel laid off 1,700 valued, long-term employees. Our cry for help was denied. Corporate America influences had silenced this Council. It was a sad day. As of today, Colorado Springs residents and businesses have all been assessed energy price increases.

#### CANDIDATE'S FOCUS/EXPERTISE/INITIATIVES:

What are your areas of special focus and/or expertise, and what initiatives would you like to undertake as a Colorado Springs City Councilperson?

From 1979 to 1983, I was elected and served honorably as a city council member in Oroville, California. - Some homeless folks have adopted a pure freedom perspective and do not want to be constrained by social norms and that includes not wanting to conform to homeless shelter requirements to include giving up on alcohol and their drugs of choice

- Finally, we have a growing crisis of a mental health issues with a segment of our society where many find themselves suffering from addiction and bounce between the streets and jail. We are unlikely to build more jails or mental health facilities. We need to attack the problem at its root.

The underlying issues will not be easy to resolve, but if we fail, so too will our community.

#### **CONSTITUTIONAL LIBERTIES:**

Being a home rule municipality is a resource and unique power granted to Colorado Springs that goes largely underused. I am a strong advocate for the use of our home rule status to stand up against state or federal abuse of power. We need to strengthen our commitment to home rule and ensure that it is permanently enshrined in the city charter. Every City Council member should be familiar with and well-versed in the rights and privileges granted to our city under home rule. Every City Council member should also be a proponent of utilizing home rule when state or federal government enact unconstitutional legislation or edicts.

#### **ANSWER:**

Current green energy initiatives being pursued by CSU, with City Council support, will come at heavy ratepayer expense. These initiatives, such as solar and wind power, are being proven in other areas of the country to be expensive to implement, ineffective in meeting the energy needs of customers (ex. Texas weekend of 2/14/21 and California since implementation) and will result in increased rates for ratepayers. Additionally, the required equipment is unreliable and once broken down or at the end of its useful life, the materials are non-recyclable, creating more landfill buildup and environmental damage. I believe CSU already provides the city of Colorado Springs with a reliable, responsible, and cost-effective power system that meets or exceeds all regulatory guidelines. If the updated and newly committed natural gas conversion is properly maintained and updated, the power system can last well into the future without diversifying into "green alternatives".

#### **BUSINESS/JOBS:**

What specifically should the City Council do to bring more businesses/jobs to Colorado Springs?

#### **ANSWER:**

The city should be incentivizing the creation or relocation of new businesses, to replace those lost to COVID, that can contribute to increasing the median income, thus offering more opportunities for raising workers' standard of living. Historically, we have been a military dependent town, which we need to continue to foster. It is important to continue to capitalize on what has made Colorado Springs what it is - our military academy, bases, and defense contractors, Olympic headquarters and facilities, two 4-year colleges, and a large community college network. We are seeing diversification (Amazon facility, technology startups, etc.), but rather than whole sale focus on diversification we need to focus on strengthening our ties with our historic and well established economic drivers and encourage diversification through other avenues, especially by inviting companies interested in supporting our traditional Colorado culture and lifestyle in lieu of changing it to be more like where they came from.

#### HOMELESSNESS/VAGRANCY:

How can the City Council address the increase in the homeless/vagrant population in our city in ways that best serve all Colorado Springs residents?

#### **ANSWER:**

Current studies/reports show that the majority of homeless choose that lifestyle even when offered work and housing alternatives. Legalizing marijuana in CO was a large contributor to the homeless-by-choice problem. A small percentage of homeless suffer from mental issues but caring for them requires a specialized plan of action and related resources which are already in place. While some citizens do experience unfortunate housing crises and need short-term help (usually the ones who pursue already available work and assistance programs) this minority group of homeless are not the primary cause of the problem. The city can help those who want it by continuing to make all available resources publicly known, but ultimately cannot help someone who does not want help. Espousing and enforcing personal responsibility and accountability, and ultimately consequences (which must be strong enough to deter the choice) for those who choose to flagrantly encamp, panhandle, and avoid assistance need to be the city council stance. Educating the public to not enable the lifestyle choice should play the largest role in addressing the homeless situation. Affordable housing is not the issue causing homelessness despite the two generally being linked together as cause and effect.
